- 1. All applicants must be **<u>18 years</u>** or over at commencement of the Course.
- The applicants first language is <u>English</u>; or the applicant has successfully completed an <u>Australian Year 12 program</u>; or successfully completed an <u>English language course</u> approved by Quality Training & Hospitality College; or an overall <u>IELTS band score of at least 5.5</u> (Academic or General); or a <u>TOEFL iBT test score between 46-59</u> or a score of <u>45 or</u> <u>higher in the Pearson Test of English</u>.
- 3. Minimum completion of Year 12 in Australia and/or International equivalent.
